MINUTES

BOARD OF COMMISSIONERS OF THE EAST SEVIER COUNTY UTILITY DISTRICT

Thursday, July 18, 2019

The Board of Commissioners of the East Sevier County Utility District met at 5:30 p.m. on Thursday, July 18, 2019, in the Office of The East Sevier County Utility District, 1529 Alpine Drive, Sevierville, TN 37876. Commissioners present were Roy Ivey, President; Barbara Darby, Secretary/Treasurer; and Janice Brooks–Headrick.

President Roy Ivey called the meeting to order at 5:34 p.m. for any old or new business.

A motion to approve the minutes of the June 13, 2019, meeting was made by Janice; Barbara seconded the motion. Motion carried.

A motion to approve the Accounts Payable listing in total as submitted was made by Barbara; Janice seconded the motion. Motion carried.

Reports

James Ford, Local Manager, having submitted the financial report, asked if any members of the Board had any questions. Having no questions, Janice motioned to approve the financials as presented; Barbara seconded the motion. Motion carried.

James then submitted the operations report. He began by thanking Roy Ivey for his assistance in repairing several line breaks that occurred since the last meeting. The new employee, Jeff Bragonier, is a hard worker who also worked skillfully on the repairs as well as many other tasks since being hired. He repaired a broken spring on the utility truck, which is now back in commission. He also worked on Wells C, D, and F and got them online again with the computer system. He lives across the street from the office, and enjoys the convenience of being close to work.

Jan asked about getting him certified. James said he will have to either get nine months of experience and take an online college course, or get one year of experience to get a license. Barbara asked if he is dependable. James said he is dependable and is a hard worker. He is also experienced in Supervisory Control and Data Acquisition (SCADA).

We completed the Alpine Drive phase of our improvement project. We repaired a service line on Alpine Drive and several other breaks and replaced a meter yoke on Yellow Pine. We took a utility truck to the transmission shop for repair. Offsite, we installed two pump kits and repaired a sewer leak at Sherwood Forest. Our June safety meeting was on

trenching and excavating. The monthly water and wastewater reports were successfully submitted to TDEC.

Persons to be Heard

The caretaker for Sharon Crabb's property at 1543 Wilhite Creek Road, asked for a one-time forgiveness on her behalf of a portion of her water and sewer bill. The hot water heater had been leaking. The caretaker found it fairly early, but circumstances prevented the replacement of the tank in a timely manner. They had called out one company only to be told when they arrived that they did not work on hot water tanks. The new tank was eventually installed, but by that time, thousands of gallons of water had leaked onto the ground, bringing her bill to \$507.73. The Commissioners agreed to allow one-half of the water overage and all of the sewer overage be adjusted off the account.

Old Business

New Business

James discussed the price of the 2018/2019 audit, which will be \$8,400 plus a possible per-hour fee, if additional time is needed to complete the Capital Assets portion. This portion is regarding the offsite wastewater facilities and the property transfers that TDEC is requiring of us. Barbara motioned to approve the cost of \$8,400 plus a possible per-hour fee for the 2018/2019 audit to be performed by Mitchell, Emert & Hill. Janice seconded the motion. Motion carried.

James requested that \$6,186 of the \$10,000 budget amount for office purchases be used to purchase a new computer, server, and installation of the United Alliance billing software for Brenda's office. Barbara motioned to approve the \$6,186 cost of a new computer, server, and installation of the United Alliance billing software for Brenda's office. Janice seconded the motion. Motion carried.

James discussed the advantages of purchasing a new utility van vs. a used utility truck. The van offers more storage space; storage bins and a rack to hold pipes can be installed to maximize storage. We would also get a much better warranty than what we would get for a used vehicle with 150,000 miles on it. The cost for a brand new utility van would be \$25,000-\$30,000, depending on whether the van already has storage racks and bins. This price is very comparable for what we would spend on a used truck. Barbara asked if it would perform well on snow-covered roads. James said if the weather is about the same as it has been in the past couple of years, we would be able to use the van 99 percent of the time. Janice motioned to approve the purchase of a new utility van at a cost of \$25,000-\$30,000. Barbara seconded the motion. Motion carried.

First Tennessee Bank has given us many options to offer convenience payments to our customers. ACH Bank Drafts will probably be the best choice; the Bank will give us a free scanner when we sign up. They charge \$0.15 per item, which will come to around \$300-\$500 per month. James offered the Commissioners the opportunity to think about it before making a final decision, and said the Bank would be willing to send employees to

the next meeting to make a presentation, giving the Board a better understanding of the process. The Board decided to approve the use of bank drafts now rather than wait. Barbara motioned to offer the use of bank drafts to our customers at a cost of \$0.15 per item, or \$300-\$500 per month. Janice seconded the motion. Motion carried.

James mentioned that Tony Sneed and Evan Romo are in Nashville for a meeting with TDEC negotiating the new Wastewater Treatment Plant requirements in an effort to keep costs for the Utility at a minimum.

Barbara requested that the next Board meeting be changed from the 8th to the 15th next month so that she can attend to some personal matters. All in attendance agreed. The next regular meeting will be held on, Thursday, August 15, 2019, at 5:30 p.m.
